1) Eligibility criteria for participation in the tender.

i. Reliable and resourceful contractors and experienced in the particular type of works having 50% credencial certificate for bill amount only during the last 5 (five) years from the date of issue of this Notice at least one work of similar nature as a prime agency under authority of State / Central Government, State / Central Government undertaking / Statutory Bodies Constituted under the Statute of the Central / State Government at least in the magnitude of 50% (fifty percent) of the amount put to tender. [Non-statutory documents]

ii. Income Tax Acknowledgement Receipt for the latest Assessment year, Pan Card, VAT Registration Certificate are to be accompanied with the Technical Bid Documents.

vi. Registered Partnership Deed for Partnership Firm only along with Power of Attorney is to be submitted. The company shall furnish the Article of Association and Memorandum. [Non-statutory documents]

vii. Registered Labour Co-operative Societies are required to furnish valid Bye Law, Current Audit Report, Minutes of last A.G.M. valid certificate from A.R.C.S. along with other relevant supporting papers. [Non-statutory documents]

viii. Joint Ventures will not be allowed.

ix. A prospective bidder shall be allowed to participate in a particular job either in the capacity of individual or as a partner of a firm. If found to have applied severally in a single job, all his applications will be rejected for that job, without assigning any reason thereof.

ii. Income Tax Acknowledgement Receipt for the latest Assessment year, P.T. Deposit Challan for the year 2014-2015, Pan Card, VAT Registration Certificate are to be accompanied with the Technical Bid Documents.

8) **Security Deposit:** Retention money towards performance Security amounting to 10% (ten percent) of the value of the work shall be deducted from the running account bill of the tenderer as per prevailing order. No interest will be paid on Security Deposit.

9) Agencies shall have to arrange land for erection of Plant & Machineries, storing of materials, labour shed, laboratory etc. at their own cost and responsibility.

10) All materials required for the proposed work including cement and steel shall be of specified grade and approved brand in conformity with relevant code of practice (latest revision) and manufactured accordingly and shall be procured and supplied by the agency at their own cost including all taxes. Authenticated evidence for purchase of cement and steel are to be submitted along with challan and test certificate. If required by the Engineer-in-Charge, further testing from any Government approved Testing Laboratory shall have to be conducted by the agency at their own cost.

12) There shall be no provision of Arbitration. The Clause No. 25 of 2911(ii) is omitted vide Notification No. 558/SPW Dated: 13th December, 2011 of the Secretary, P.W. Department.

13) Bid shall remain valid for a period not less than 120 (one hundred twenty) days from the last date of submission of Financial Bid / Sealed Bid. If the bidder withdraws the bid during the validity period of bid, the earnest money as deposited will be forfeited forthwith without assigning any reason thereof.

14) Tender Details

i) Date of Uploading Estimate Tender Paper = 20/02/2018.

ii) Tender Paper available from 21/02/2018 to 28/02/2018.

iii) Last date of submission of Demand Draft for Earnest Money & Tender Paper = 06/03/2018.

iv) Date for Opening Tender = 08/03/2018.

15) The Prospective Bidder shall have to execute the work in such a manner so that appropriate service level of the work is maintained during progress of work and a period of 1 (one) year from the date of successful completion of the work to the entire satisfaction of the Engineer-in-Charge. If any defect / damage is found during the period as mentioned above, the contractor shall make the same good at his own cost to the specification at par with instant project work. On failure to do so, penal action against the contractor will be imposed by the Department as deem fit. The contractor may quote his rate considering the above aspect.

Refund of Security Deposit will only be made after successful maintaining of appropriate service level of the work as mentioned above for 1 (one) year from the date of completion of the work. Provision in Clause No. 17 of W.B. Form No. 2911(ii) shall be treated as superseded.

17) **Earnest Money:** The amount of Earnest Money @ 2% (two percent) of the Estimated Amount put to tender in the shape of Bank Draft / Pay Order of any nationalised bank drawn in favour of the *Teacher-in Charge, B.B.College, Asansol* against the work.

18) The Bidder, at his own responsibility and risk is encouraged to visit and examine the site of works and its surroundings and obtain all informations that may be necessary for preparing the Bid and entering into a contract for the work as mentioned in the Notice Inviting Tender, before submitting offer with full satisfaction, the cost of visiting the site shall be at his own expense.

19) The intending Bidders shall clearly understand that whatever may be the out come of the present invitation of Bids, no cost of Bidding shall be reimbursable by the Teacher in Charge, B.B.College Asansol reserves the right to accept or reject any offer without assigning any reason whatsoever and is not liable for any cost that might have been incurred by any Tenderer at the stage of Bidding.

20) Refund of EMD: The Earnest Money of all the unsuccessful tenderers deposited in favour of the Teacher in charge, B.B.college, Asansol will be refunded by Teacher-in Charge, B.B.College, Asansol on receipt of application from tenderers on the basis of Notification.

21) Prospective applicants are advised to note carefully the minimum qualification criteria as mentioned in 'Instructions to Bidders' stated in Section – 'A' before tendering the bids.

22) Conditional / Incomplete tender will not be accepted under any circumstances.

23) The intending tenderers are required to quote the rate online.

24) Contractor shall have to comply with the provisions of (a) the contract labour (Regulation Abolition) Act. 1970 (b) Apprentice Act. 1961 and (c) minimum wages Act. 1948 of the notification thereof or any other laws relating there to and the rules made and order issued there under from time to time.

25) Guiding Schedule of Rates: Rates have been taken from P.W.D. (W.B.) Schedule of Rates for "Building Works" and "Sanitary & Plumbing Works" effective from 1st April 2015. Duly vated by Superintendent Public Health Engineer, Government of West Bengal.

26) During scrutiny, if it comes to the notice of the tender inviting authority that the credential or any other paper found incorrect / manufactured / fabricated, that bidder would not be allowed to participate in the tender and that application will be rejected without any prejudice.

27) Teacher-in Charge, B.B.College, Asansol reserves the right to cancel the N.I.T. due to unavoidable circumstances and no claim in this respect will be entertained.

28) If there be any objection regarding prequalifying the Agency that should be lodged on line to the building Committee/ Plaining Board within 2 (two) days from the date of publication of list of qualified agencies and beyond that time schedule no objection will be entertained by the building Committee/ Plaining Board.

29) Before issuance of the WORK ORDER, the tender inviting authority may verify the credential and other documents of the lowest tenderer if found necessary. After verification if it is found that the documents submitted by the lowest tenderer is either manufactured or false in that case work order will not be issued in favour of the said Tenderer under any circumstances.

30) If any discrepancy arises between two similar clauses on different notification, the clause as stated in later notification will supersede former one in following sequence:

- 1) Form No. 2911(ii)**
- 2) N.I.T.**
- 3) Special Terms & Conditions**
- 4) Technical Bid**
- 5) Financial Bid**

31) Qualification criteria: The tender inviting and Accepting Authority through a “Building Committee/ Planning Board” will determine the eligibility of each bidder. The bidders shall have to meet all the minimum criteria regarding:

- 1) Financial Capacity**
- 2) Technical Capability comprising of personnel & equipment capability**
- 3) Experience / Credential**

The eligibility of a bidder will be ascertained on the basis of the document(s) in support of the minimum criteria as mentioned in (a), (b) & (c) above and the declaration executed through prescribed affidavit in non-judicial stamp paper of appropriate value duly notarized. If any document submitted by a bidder is either manufactured or false, in such cases the eligibility of the bidder / tenderer will be rejected at any stage without any prejudice.

32) Escalation of Price on any ground and consequent cost over run shall not be entertained under any circumstances. Rates should be quoted accordingly.
