It was stipulated in Government Order No.1080-Edn(CS) dated the 28th October, 1970 by which the integrated scale of pay was introduced, that financial assistance on the terms contained in that Government Order and subsequent Govt. Orders on the subject, would be admissible to the colleges only in respect of posts which had already been approved by the Government. Pending the fixation of the norm of workload for college teachers, the Governor was pleased to declare in G.O. No.1080-Edn(CS) dated the 28th October, 1970 that posts created in affiliated including sponsored colleges on or after the 1st April, 1966 and existing on the 1st September, 1970, should be treated as approved without scrutiny for facilitation the release of financial assistance to the colleges concerned.

The Governor is now pleased to direct that posts created in affiliated and sponsored colleges prior to 1st April, 1966, which are awaiting the approval of the Government should also be deemed to be approved without scrutiny.

The Government, however, reserves its right to scrutinise the admissibility of posts that may have to be created in affiliated including sponsored colleges in future. No additional posts in any such college should be created without the prior approval of the Government.

This orders issues with the concurrence of the Finance Department vide their U.O. No. B.VI/4022 dated the 16th Nov.1970.



Recruitment to all the additional non-teaching posts should be made in accordance with the recruitment rules of the college and Government circulars in this respect.

All part-time posts (non-teaching) should be abolished as soon as the whole-time posts now approved are filled up.

The posts of Mali & Cleaner are not admissible. These posts should be abolished forth with and the incumbents thereof may be absorbed in any two of the three posts of Bearer/Peon in the General Section of the Morning Shift, now approved, or, in any other new posts of similar category as may be suitable, with continuity of service.

The excess posts of Night Guard in the Day Shift should also be abolished and the incumbents thereof absorbed in the two posts of Durwan (one in the Morning and one in the Evening) now approved or in any other similar posts approved by Govt. for its Day/Morning/Evening Shift with continuity of service.

Out of total 56 posts now approved, there will be 52 posts to which fresh appointment can be made after absorbing incumbents of four excess/inadmissible posts. Of the 52 posts the college authorities may fill up twenty five posts in 1982-83 and the remaining twenty seven posts in 1983-84. The college may choose the twenty five posts for 1982-83 and approach Govt. for approval before making recruitment.

The Governor is further pleased to direct that the following posts now existing in the college should be re-designated in the following manner.
